

**AMENDMENT OF THE RIGHT-OF-WAY LEASE
FOR THE
TRANS-ALASKA PIPELINE
ADL 63574**

**Sagavanirktok River Buried Spur Dike
PLMP 85**

This is an Amendment to Exhibit D, Description of the Right-of-Way for Related Facilities of the RIGHT-OF-WAY LEASE FOR THE TRANS-ALASKA PIPELINE, ADL 63574, hereinafter referred to as AMENDMENT.

The RIGHT-OF-WAY LEASE FOR THE TRANS-ALASKA PIPELINE dated May 3, 1974, ADL 63574 was recorded in the Barrow Recording District in Book 24, Pages 001 through 0107 on July 16, 1979. The RENEWAL AND AMENDMENT OF RIGHT-OF-WAY LEASE FOR THE TRANS-ALASKA PIPELINE AND ASSOCIATED RIGHTS, ADL 63574, which became effective May 2, 2004, was recorded as Document No. 2002-001065-0, Pages 1 through 30 on December 16, 2002 in the Barrow Recording District.

This AMENDMENT is made and entered into and becomes effective this 17th day of April, 2006 by and between the STATE OF ALASKA located at 411 West 4th Avenue, Suite 2C, Anchorage, Alaska 99501 by the Commissioner of Natural Resources hereinafter referred to as COMMISSIONER, and Alyeska Pipeline Service Company as agent for the Trans-Alaska Pipeline System owner companies located at P.O. Box 196660, MS 569, Anchorage, Alaska 99519-6660 hereinafter referred to as LESSEE.

WHEREAS, the LESSEE has applied to amend the existing Right-of-Way Lease ADL 63574 to include additional State of Alaska land for a temporary construction zone to accommodate the construction and maintenance of a buried spur dike between Spur Dike 1 and Spur Dike 2 on the west bank of the Sagavanirktok River near pipeline milepost (PLMP) 85. This will enhance the integrity of the Trans-Alaska Pipeline System by protecting the above ground pipe in this area where a side channel of the Sagavanirktok River is only 150 feet from vertical support members that were not designed or built for main channel scour.

NOW THEREFORE, the COMMISSIONER and LESSEE agree to amend the RIGHT-OF-WAY FOR THE TRANS-ALASKA PIPELINE, ADL 63574 to include the lands within the Barrow Recording District described as:

Township 4 South, Range 14 East, Umiat Meridian, Alaska.

Section 7, SE4, and Section 18, NE4, those lands within an area approximately 830 feet long by 300 feet wide situated adjacent to and east of the existing TAPS right-of-way as depicted on the attached plan view drawing submitted after the application labeled "PLMP 85 SAG RIVER ENTRENCHED SPUR DIKE 1A, PLATE 1 – REV 1", AT: SE1/4 SEC.7 & NE1/4 SEC. 18, T4S, R14E, UMIAT MERIDIAN, ALASKA.

Aggregating 6.0 acres, more or less.

The lands described above are incorporated into and made a part of the RIGHT-OF-WAY LEASE FOR THE TRANS-ALASKA PIPELINE dated May 3, 1974, ADL 63574 and the RENEWAL AND AMENDMENT OF RIGHT-OF-WAY LEASE FOR THE TRANS-ALASKA PIPELINE AND ASSOCIATED RIGHTS, ADL 63574, effective May 2, 2004.

The lands needed to accommodate this buried spur dike after construction will be less than those described above. After construction, Alyeska Pipeline Service Company will submit an as-built drawing for the Commissioner's approval. The as-built drawing will tie the buried spur dike to the pipeline centerline. Upon Alyeska's acceptance of the Commissioner's approval of the as-built, Exhibit D, Right-of-Way for Related Facilities of the RIGHT-OF-WAY LEASE FOR THE TRANS-ALASKA PIPELINE, ADL 63574 will be amended to reflect the final, amended legal description.






